## STATEMENT REGARDING REACH

Registration, Evaluation, Authorization and Restriction of Chemicals (REACH) REACH is a European Union regulation concerning the Registration, Evaluation, Authorization and restriction of Chemicals. It became effective on 1st June 2007 (latest **SVHC list from 16.07.2019**) and replaces a number of European Directives and Regulations with a single system. Melchers Techimport GmbH wishes to assure its business partners that it will take all appropriate precautions to prevent disruption to business and to ensure continuity of product supply to its customers.

Specifically, we confirm that;

1. We are aware of the REACH regulations; the potential implications for our business; and our obligations to ensure business continuity.
2. We do not manufacture or import any substances that require registration under REACH regulations.
3. None of our products are intended to release any chemical.
4. In the extremely unlikely event of a Melchers Techimport GmbH product containing SVHCs above 0.1% by weight, and fulfilling the other criteria published in REACH Legislation, Melchers Techimport GmbH would comply with the notification procedures required by the authorities.
5. We have or will contact suppliers who supply us with substances that may likely require registration under REACH regulations to request confirmation that the chemicals of concerns were either registered or they have requested their downstream suppliers to do so.
6. We will take appropriate action in response to any to business risks arising through supplier failure to cooperate and support us in this project.
7. We will do our utmost to ensure that continuity of supply of our products will not be adversely affected by issues arising from the REACH regulations.
